**Annual Year End Report (as of 12/31/2020):**

- Income from donations: \$12,824.00 compared to last year's \$6,885.00 (five months).
- Expenses: \$2,243.74 compared to last year's \$38.68.
  - Professional Fees: 630.27 (Form 1023 Filing Fee: \$605.27; State Corporation Filing Fee: \$25.00).
  - Computer and internet Expenses: \$1,431.77 (Upgraded hosting site and improved security for money transfers).
  - Dues and Subscriptions: \$150.00 (Yearly PO Box Rental Fee).
  - Postage and Delivery: Stamps \$11.00 (Debit card activation).
  - Ministry Supplies: \$20.70 (Communion Supplies).
- Total Cash Flow: \$6,846.32
- Net Ordinary Income: \$10,580.26 compared to last year's \$6,846.32.
- Cash in Bank: \$17,121.58 compared to last year's \$6,849.32.

**Vision Moving Forward:**

- Discussed the need to find a home so that we can work on expansion.
- Discussed the need to promote the ministry in the Community by getting involved in some community service projects.
- Discussed currently updating the website, including BOD page, Donation page, General Privacy, Donor Privacy, Terms Of Use, Copyright pages, and financial information pages.
