**Year in Review:**

- We continue to expand our social media ministry footprint on Facebook, Twitter, Instagram, and Pinterest. We have added a new KW Ministries YouTube Channel to our social media platform. We have a presence in the US and abroad, with an estimated 30,000 combined followers on all platforms. We continue to seek more markets and avenues to expand our ministry footprint.

**Annual Year End Report (as of 12/31/2022):**

- Income: \$10,928.10 compared to last year’s \$9,362.00 (up about 17%).
  - Tithes and Offerings: \$10,606.40
  - Product Sales: \$321.70
- Expenses: \$3,496.60 compared to last year’s \$5,240.47 (down about 67%).
  - Computer and Internet Expenses: \$2,857.09

  - Online Bookkeeping: \$27.50
