Purpose of Meeting

Year in Review:

- We are excited about our new website. We want to thank Stimulus Advertising for donating the upgraded website to the ministry. We totally appreciate it.
- We continue to expand our social media ministry footprint on Facebook, X (Twitter), Instagram, Pinterest, Linked-In, YouTube, and Threads. We have a presence in the US and abroad, with an estimated 30,800 combined followers on all platforms and about 99,000 interactions per month. We continue to seek more markets and avenues to expand our ministry footprint.
